# **QUALITY CONTROL (QC)**

Over the past year, the count adjustment method with redemption centres (RC) has resulted in overall continued accuracy. As of June 1st, reported accuracy was 0.2%, which, again, is close to perfect. Currently, there are eight redemption centres in the accelerated mode.

### NEW ENCORP WEBSITE



We are putting the finishing touch on a revised architecture for the Encorp website. This new site will provide an overview of all current projects and all published information featured in our quarterly newsletters. The site will be constantly evolving as new information becomes available, somewhat like a live newsfeed. The site will also allow viewers to access information such as the Beverage Containers Act, the Regulation on Beverage Containers, the beverage container product lists, the incident report form and Encorp's contact information. We anticipate the revised site to be online by August 1st.

### **CONFIDENTIALITY BETWEEN DRIVERS AND RCS**

# NEW BULK BAGS


Every year, we replenish our inventory of bulk bags. With a similar design as last year, new bags have been designed with a duffle and string closure, a see-through window, added handles for easy pick-up and a maximum fill-line indicator. These new bags are similar in size (1m3) and weight (200g) and have started appearing in redemption centres.

# STORAGE CAPACITY AUDITS AT ALL RCS IN NB

This summer, Encorp has hired a consultant to assess the storage capacity of all redemption centres in New Brunswick. The purpose is to use this crucial information to improve everything from redesigning bulk bags to evaluating the need for compaction equipment for RCs. Encorp has hired Yanick Sirois to compile this data on our behalf. Yanick has extensive waste management experience and will help us with this project. We hope to commence the work in midsummer. # RESEARCH PROJECTS

# **RE360**

The reusable \$3/60 box, made from recycled plastic and currently being tested in two redemption centres (Moncton and Dieppe) is showing promising results. Preliminary data so far indicates that customers are satisfied with the expediency of the program while participating redemption centres are stating that the accuracy is just fine. If your centre wants to take part in this pilot project, please send us a message.



# **RE-CENTRE EXTENSION**

The Re-Centre automated bag-drop technology tested since 2014 will now move to a new phase. First, starting on September 1st, 2017, current Re-Centre units will be managed by existing redemption centre operators in the Moncton-Dieppe area. This will allow existing operators to acquire real-time experience with this technology. Secondly, we hope to test a new approach: using fix-count bags (\$2/40) in a retail environment. Again, this unit will be automated, and those who sign-up to this pilot project will be able to get their container refund at the participating retailer. It's expected that this unit will be situated in the parking lot of an existing retail/grocery store in the test region (Moncton). All three Re-Centre depots will be managed by redemption centre operators and will allow for a first-hand experience with this technology.
