ACCURACY

As of December 31st, 2017, quality control

with RCs has resulted in an overall accuracy rate of 0.25% There are currently 9 RCs in the accelerated mode.

Our sampling model for quality control also includes assessments of out-of-province containers and volume fluctuations (comparative analyses) to detect irregularities.

The return rate as of December 31st (rolling-12 month period) was 69%.

RE-CENTRE MOVING TO NEXT PHASE



The transition with Valley Redemption Centre for the Re-Centre pilot project has gone-off without any glitches. As of October 2017, Valley Redemption Centre collects from the two existing Re-Centre depots (pilot project) in the Moncton area and processes the collected containers at their redemption centre location on Collishaw Street in Moncton. One Re-Centre depot unit was physically moved from Killam Drive to Valley's Collishaw location on October 17. Valley personnel have not encountered any insurmountable issues with regards to the extra volume generated by the unmanned drop-off depots or the data management (Re-Centre participants) required in this process. We are closely monitoring the processing schedules and customer satisfaction comments with current Re-Centre members.

REGIONAL MEETING-RECEPTION

October 30th, 2017 marked the end of a consultation process that included 10 meetings/receptions across New Brunswick with redemption centre (RC) owners, staff and research project participants. In all, 221 participants attended these meetings, which also included Department of Environment and Local Government officials. Many excellent comments emerged from these gatherings. From an Encorp perspective, the value from this exercise proved very positive and constructive.

MANY MOVING PARTS TO THE PROGRAM

Encorp's most serious headache over the late fall period has been the timely tracking of bulk bags (Sort #3) in the compaction trucks (Nexgen). At times, Encorp was receiving the information (collection data) from the compaction trucks with a few days delay. This caused a domino effect that resulted in payments to RCs being delayed for a few days. Only certain RCs were witnessing delays in their payments. These minor glitches created havoc for both the affected RCs and Encorp staff alike. This problem has now been corrected with the compaction trucks being equipped with on-board Wi-Fi connections. We would like to thank RCs who initially flagged the issue and waited patiently while we worked with our service provider on finding a solution to this issue.
