INSTRUCTIONS FOR FILLING THE FORM

Type in information regarding each beverage product you wish to register. Send the completed form to the appropriate contacts for each province in which the products are being sold.

PRODUCT NAME

Indicate the beverage product's name.

PRODUCT FLAVOUR

Indicate the flavour of the beverage product, if applicable (for example: strawberry).

CONTAINER SIZE

Indicate the size of the beverage product container in millilitres (ML).

CONTAINER MATERIAL TYPE

Specify the material the container is made of.

CONTAINER MATERIAL COLOUR

Specify the colour of the container (only for GLASS, PETE 1, HDPE 2). This refers to the colour of the material the container is made of, not the colours on the label or wrapping.

UPC

Indicate the UPC on the beverage product container. Include all digits of the UPC number. In case of multi-packs, if beverage container does not have a UPC on its label, leave UPC field blank - do not provide UPC on outer wrapping.

LABELLING REQUIREMENTS FOR BEVERAGE PRODUCTS

Return for Refund Message

Each province requires that all beverage containers covered by local acts and regulations carry a label which includes a highly visible "Return for Refund" message. Multiple variations of wording are acceptable provided the concept of a refund is evident and the message appears in both English and French.

Size

To ensure the message is readily visible, a minimum letter size of 3.2 mm (1/8 in.) is required.

Location

The message must be located on the container where it is readily visible and must remain on the container when empty. In other words, it cannot be located on a cap or lid which may be discarded.

Label Sample

In order for a beverage to become registered, a sample of the label must accompany this form, clearly showing the "Return for Refund" message.

Note that the "Return for Refund" message does not need to be included on outer wrapping for multi-packs.
