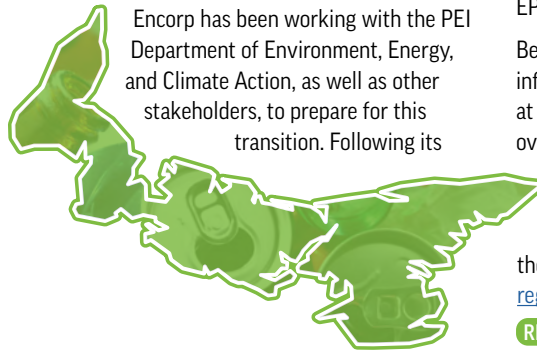
ENCORP ATLANTIC WELCOMES ISABELLE FAUCHER TO ITS BOARD OF DIRECTORS

UPDATES ON PEI TRANSITION TO EPR

The Government of Prince Edward Island (PEI) is [transitioning its Beverage Container Program to an Extended Producer Responsibility \(EPR\) model](#) effective April 1, 2026.



Encorp has been working with the PEI Department of Environment, Energy, and Climate Action, as well as other stakeholders, to prepare for this transition. Following its

successful leadership of New Brunswick's shift to EPR in 2024, Encorp has been chosen as the producer responsibility organization for PEI and has submitted a Stewardship Plan for the new EPR Program.

Beverage producers are invited to attend an informational webinar on November 20, 2025, at 1:00 p.m. AST. This session will provide an overview of the confirmed details of PEI's new

EPR Program, as outlined in Encorp's approved Stewardship Plan. A second webinar will be held in February 2026, following the official opening of registrations. [You can register for both webinars on our website.](#)

NB CRF RATES – APRIL 1, 2026

Please note that the container recycling fee (CRF) rates in effect as of April 1, 2026, will remain unchanged from the current rates - no decrease or increase in CRF rates is planned. [READ MORE](#)

CONTAINER TYPE*	CURRENT CRF (APRIL 1, 2025 - MARCH 31, 2026)	NEW CRF (APRIL 1, 2026)
Aluminum	2 cents	2 cents
PET/HDPE (non-alcohol)	4 cents	4 cents
PET/HDPE (alcohol)	1 cent	1 cent
All other plastics	1 cent	1 cent
Non-refillable glass	10 cents	10 cents
Refillable glass (beer)	0 cents	0 cents
Steel	3 cents	3 cents
Cartons (Polycoat containers + wine boxes/bag-in-box)	0 cents	0 cents

*Applies to all beverage containers 5 L and under for [products that fit the Designated Materials Regulation's definition of "beverage."](#)
